- CUA-funded Undergraduate scholarships and grants are not available during the summer term. Federal grants and loans may be available if eligibility remains for the 2016-17 academic year. Graduate scholarships and grants are subject to the policies of the individual graduate school.
- Enrollment Requirements: **Undergraduates: minimum of 6 credits. Graduate: minimum of 4 credits or be enrolled in dissertation guidance.** If you drop below the required credits for the summer, your aid will be canceled and/or you may owe the University any outstanding balances.
- **Loans will disburse to your student account no sooner than 10 business days prior to the start of your first summer session.**
- If you did not apply for federal financial aid for Fall 2016 or Spring 2017, you are required to fill out a Free Application for Federal Student Aid (FAFSA) for the 2016-2017 year. Due to the short length of the summer sessions, the FAFSA should be filled out as soon as possible. The Office of Student Financial Assistance must receive your FAFSA results at least two weeks before your last session of enrollment to ensure processing your aid. Deadline: June 30. Financial Aid cannot be processed once your summer classes have ended.
- **This application must be received at least two weeks prior to the end of the semester. Applications submitted after this date may not be able to be processed in time to award aid for the semester in question.**
