	You must provide a copy of your marriage certificate as recorded by a court in the state in which you were married. If you do not have a marriage certificate answer "NO."				
2	At the beginning of the 2017-2018 school year will you be working on a master's or doctorate program? Question on 48 on 17/18 FAFSA.				
	You should answer "Yes" if the above statement is true. A member of the Office of Student Financial Assistance will verify your program.				
3	Are you currently serving on active duty in the military for purposes other than training? Question on 49 on 17/18 FAFSA.				
	You must provide a copy of your current military orders if you answered "Yes."				
1	Are you a veteran of the US Armed Forces? Question on 50 on 17/18 FAFSA.				
	You should answer "Yes" if the above statement is true. A member of the Office of Student Financial Assistance will review the FAFSA veteran's match with the VA. Please note that if no match was indicated, we may request the Member-4 copy of your DD214.				
5	Do you now or will you have children who will receive more than half of their support from you from July 1, 2017 to June 30, 2018? <i>Question on 51 on 17/18 FAFSA.</i>				
	You should answer "Yes" if the above statement is true. A member of the Office of Student Financial Assistance will review your household size and may contact you for additional follow up information as necessary.				
ó	Do you have dependents (other than your children or spouse) who live with you and who receive more than half of their support from you from now, and through June 30, 2017? <i>Question on 52 on 17/18 FAFSA</i> .				
	You should answer "Yes" if the above statement is true. A member of the Office of Student Financial Assistance will review your household size and may contact you for additional follow up information as necessary.				
7	At any time since your turned age 13, were both your parents deceased, were you in foster care or a dependent/ward of the court? <i>Question 53 on 17/18 FAFSA.</i>				
	If "Yes," you must provide court documentation from your home state documenting your foster care or ward of the court status. If you do not have such a court order or the court order is no longer in effect, you should answer "NO" to this question.				
3	On the date you completed the FAFSA, are you or were you an emancipated minor as determined by a court in your state of legal residence? <i>Question 54 on 17/18 FAFSA</i> .				
	If "Yes," you must provide a copy of a court's decision that you are an emancipated minor. The court must be located in your state of legal residence. If you do not have such a court order, you should answer "NO" to this question.				
)	On the date you completed the FAFSA, are you or were you in legal guardianship as determined by your state of legal residence? <i>Question 55 on 17/18 FAFSA</i> .				
	A caregiver or other person with whom you are living is only considered a legal guardian if a court in your state of legal residence has established guardianship, in most cases custody does not qualify. You should answer "YES" if you can provide a copy of a court order from your home state indicating that legal guardianship was established. If you are living with a caregiver, but that caregiver is not your legal guardian as established by a court, you should answer "NO" to this question.				
0	At any time on or after July 1, 2016 did your high school or school district homeless liaison, determine that you were an unaccompanied youth who was homeless or were self-supporting and at risk of homelessness? <i>Question 56 on 17/18 FAFSA</i> .				
	Answer "YES" if you received a determination at any time after July 1, 2016, that you were an unaccompanied youth who was homeless. You must provide a copy of this documentation with this form. Answer "NO" if you are <u>not</u> homeless or at risk of being homeless or if you cannot provide a copy of the determination.				
11	At any time on or after July 1, 2016, did the director of an emergency shelter or transitional housing program funded by the U.S. Department of Housing and Urban Development determine that you were an unaccompanied youth who was homeless or were self-supporting and a risk of homelessness? <i>Question 57 on 17/18 FAFSA</i> .				
	Answer "YES" if you received a determination at any time after July 1, 2016, that you were an unaccompanied youth who was homeless. You must provide a copy of this determination with this form. Answer "NO" if you are <u>not</u> homeless or at risk of being homeless or if you <u>cannot</u> provide a copy of the determination.				
12	At any time on or after July 1, 2016, did the director of a runaway or homeless youth basics center or transitional living program determine that you were an unaccompanied youth who was homeless or self-supporting and at risk of being homeless. <i>Question 58 on 17/18 FAFSA.</i>				
	Answer "YES" if you received a determination at any time after July 1, 2016, that you were an unaccompanied youth who was homeless. You must provide a copy of this determination with this form. Answer "NO" if you are <u>not</u> homeless or at risk of being homeless or if you <u>cannot</u> provide a copy of the determination.
